# 1. Project Background

Years of drug addiction and mental health struggles began to erode his life, dragging the once-dominant champion into a deep abyss. In 2015, Odom was found unconscious in a Nevada motel due to a drug overdose. His heart stopped multiple times, and he hovered between life and death. Through the decentralized power of blockchain, ODOM carries Lamar Odom's spirit of rebirth and his message of sober living — spreading it across the world to inspire transformation, healing, and strength.

## **1.2 The Global Addiction Crisis and the Public Welfare Dilemma**

Addiction is not merely a personal issue—it is a hidden global epidemic, a silent war that relentlessly strips away dignity and life. While Lamar Odom's story is striking, he is not an isolated case—he represents the lived reality of millions who continue to struggle in the shadows.

According to a report by the United Nations Office on Drugs and Crime (UNODC), over 360 million people worldwide are affected by some form of addiction—ranging from illicit drugs, alcohol dependency, and gambling, to emerging behavioral dependencies like social media addiction. Even more alarming is the rising proportion of youth, marginalized populations, and psychologically vulnerable individuals among those affected. Anxiety, depression, and self-harm have become ticking time bombs in the global public health landscape.

At the same time, traditional public health systems and charitable institutions are faltering. Faced with a surging mental health crisis, social resources are unevenly distributed, and support mechanisms remain sluggish, failing to form a sustainable global intervention network.

Today's public welfare landscape faces four critical challenges:

- ① Lack of financial transparency: Donation flows are difficult to track in real time, undermining public trust.
- ② Regional inequality: Resources are heavily concentrated in developed Western countries, while developing nations lack the infrastructure to support recovery.

- ③ Weak incentive mechanisms: Participants in charitable efforts receive little recognition or tangible reward, discouraging broad engagement.
- ④ Absence of unifying symbols: Without a shared emotional language or global resonance, public welfare narratives remain fragmented and disjointed.

On this fractured ground, ODOM proposes a new paradigm. ODOM seeks to merge the ideals of sobriety and self-discipline with the transparency of blockchain, the incentive potential of tokenomics, and the power of emotional consensus—aiming to dismantle old barriers and rebuild the architecture of trust in public welfare participation.

This is not just a technological evolution—it is a spiritual and cultural revolution. A sober movement for the on-chain world, reimagining how humanity combats addiction, builds solidarity, and spreads hope.

## 1.3 How Blockchain Empowers Public Welfare

In an era of scarce trust, blockchain is not only the technological foundation of the financial revolution but also the key to reshaping the public value distribution system.

The ODOM project is built on decentralization, combining community consensus and spiritual symbolism to create a new "Web3 public welfare + cultural movement" model. The limitations of traditional public welfare are precisely what ODOM seeks to break through using the power of blockchain:

**Transparency:** All public welfare funding is executed via on-chain contracts, fully traceable and verifiable, ensuring that every resource is truly directed towards real-world projects such as addiction recovery centers and mental health education.

**Consensus-driven:** Holding ODOM tokens is not just an asset—it's a badge of honor representing your role in co-creating the culture of sobriety. Every token holder has the right to propose, decide, and spread the message, collectively making sobriety a globally shared cultural symbol.

Incentive mechanisms: Through airdrop rewards, content-based incentives, and support for early believers, creators, and public advocates, ODOM empowers action-driven contributors—moving beyond the limitations of traditional donations.

Long-tail value release: Transforming one-time donations into ongoing on-chain incentives and impact proof, public welfare participation becomes a long-term positive force that runs through the entire lifecycle of the token, rather than a short-term action.

Public welfare should not be an isolated cry for help, but rather the convergence of global consensus. It is a new narrative built together on-chain by everyone who believes in sobriety, self-discipline, and hope. In ODOM, sobriety is not a solo performance—it is a collective celebration on-chain. Public welfare is not just about donating money; it is the ticket to co-creating the universal consensus.

## 2. Mission and Vision

### 2.1 Core Slogan and Spiritual Essence

This is not just a slogan, but a call for collective awakening—an initiation ritual for self-awareness among Web3 natives. ODOM is not just an ordinary Meme Coin. It was born from the scars of real life and carries profound questions about dignity and self-control. We believe that on the blockchain, within the consensus, and in every belief of "sobriety," a cultural movement is brewing that does not rely on shouting, but on persistence.

**The spiritual core of ODOM is built on three core pillars:**

**Sobriety:** Representing a clear recognition of reality and the courage to face it. Sobriety is not just about quitting drugs; it's about seeing the true nature of temptation and maintaining a life of mental independence. In an era of information overload and pleasure saturation, sobriety has become a rare and valuable skill.

**Discipline:** Discipline is not a shackle; it is the shield of freedom. What ODOM represents is the courage to choose long-term value over short-term gratification.

**Rebirth:** Lamar Odom's story is not an endpoint; it is a new beginning. Every person may have fallen, but everyone deserves a chance for a fresh start. ODOM is about embracing, respecting, and witnessing anyone who chooses the path of a sober life within the community.

## 2.2 Vision

**ODOM was born for charity and sobriety, becoming a symbol of both culture and action.**

In the past, Meme Coins were often seen as symbols of entertainment and speculation, but the goals of ODOM go far beyond that. We firmly believe that Meme Coins can bring not only short-term entertainment but also serve as a symbol of culture, a vessel for global consensus, and a call for collective action.

The vision of ODOM is: to create a "sobriety culture" that transcends cultures, languages, and regions through the decentralized power of blockchain, making "rejecting temptation and maintaining discipline" no longer a heavy commandment, but a lifestyle that is recognized globally, widely practiced, and even celebrated.

Sobriety becomes a trend; discipline becomes the core value of the community; ODOM becomes the symbol of your spirit.

## 2.3 Long-Term Mission

The mission of ODOM goes far beyond short-term celebrity effects or localized charitable funding. Our goal is to fundamentally reshape the global understanding and attention towards "healthy life choices" through real role models and transparent mechanisms. Our long-term mission includes:

- Turning celebrity influence into sustained, on-chain charitable actions, not just media buzz;
- Transforming the community into active spreaders and guardians, rather than passive onlookers;
- Ensuring that every struggler knows—they are not fighting alone.

Blockchain not only creates wealth, but it can also convey faith and values; Meme Coins not only attract attention, but they can also gather hope and strength. ODOM is the bridge that connects "faith, action, and consensus." Through this bridge, we gather the strength of each individual to jointly drive this global movement that changes destinies.

## 3. ODOM Token Model

### 3.1 Basic Information

Token Name: ODOM

Total Supply: 3,000,000,000,000 tokens

### 3.2 Token Allocation

To achieve ODOM's long-term charitable mission, the organic integration of community consensus, and decentralized governance, we have designed a transparent and fair token allocation plan. This ensures that every stage of the process can incentivize the participation of the global community and drive the realization of the project's mission.

Allocation Category	Percentage	Description
Public Welfare Fund and Founder Incentives	5%	This portion of tokens shall remain locked for the long term and be dedicated exclusively to supporting public welfare initiatives such as global drug rehabilitation centres and mental health education. These tokens may only be unlocked once the total size of the fund reaches USD 10 billion. This mechanism is designed to reinforce the project's core mission of "sobriety and self-discipline", safeguard the independence of funds, and ensure the continuity of philanthropic activities.
	5%	Allocated to Lamar Odom himself, as a reward for his personal initiation and leadership in this philanthropic mission. This portion will be fully locked until the market capitalization of \$ODOM exceeds \$15 billion, demonstrating a long-term commitment through tangible actions.
Trump Dinner Event	20%	To support the community-initiated "Trump Dinner Participation Plan," a smart contract will be used to securely collect TRUMP tokens from participants. After the event concludes, all tokens will be returned in full to their original addresses. Additionally, all contributing addresses will receive an airdrop of \$ODOM tokens as a reward.
Market Circulation	70%	These tokens will be fully allocated for public market circulation, with no reserved or locked tokens, ensuring ample liquidity from the initial issuance.

## 3.3 Deflationary and Stability Mechanism

ODOM introduces a "dual-driven" value repatriation mechanism: continuous deflation + stablecoin repurchase, which not only maintains market stability but also continuously enhances token scarcity, strengthening long-term value support.

### 3.3.1 Public Welfare Donation Burn Mechanism

We will continue to receive donations from individuals, charitable organizations, businesses, and community channels worldwide. 50% of the external donations received will be used to repurchase ODOM tokens from the market, and the purchased tokens will be sent to an irreversible black hole address for permanent destruction.

The entire process of repurchase and destruction will be carried out on-chain. The sources of donations, usage of funds, and destruction records will all be transparently and publicly disclosed, ensuring that every charitable donation is accompanied by genuine, verifiable value feedback, further strengthening the deflationary model and the trust base of the community.

### 3.3.2 Stablecoin Repurchase Mechanism

To ensure strong value backing for the ODOM ecosystem's stablecoin \$USDO, the project will adopt a 100% tokenized U.S. Treasury-backed issuance and management mechanism. All assets backing \$USDO will be on-chain and verifiable tokenized U.S. Treasury securities, ensuring security, transparency, and resilience.

The project team has established the following revenue distribution mechanism based on yields generated from U.S. Treasury investments, aimed at driving the value growth of the \$ODOM token and incentivizing community participation:

- 25% of the yield will be used to buy back and burn \$ODOM tokens, continuously reducing the circulating supply and increasing long-term scarcity.
- 25% of the yield will be distributed to \$ODOM holders as dividends, allocated on-chain according to their holdings, encouraging long-term holding.

· The remaining 50% will be allocated to operations, risk reserves, and ecosystem expansion. This mechanism not only establishes a reliable value-anchoring system through the stablecoin, but also channels stable yields back into the token economy, fostering a virtuous cycle and sustainable growth for the ODOM ecosystem.

All U.S. Treasury asset allocations, yield sources, buyback-and-burn activities, and dividend data will be transparently published on-chain in real time, ensuring full community auditability and eliminating any form of opaque operations or interest misalignment.

## 3.4 Lock-Up and Unlock Mechanism

To further demonstrate the long-term nature and transparency of the ODOM project, we have designed a rigorous lock-up and unlock logic:

### 3.4.1 Personal Vesting Mechanism for Lamar Odom

Lamar Odom's personal allocation of 5% of the tokens will be fully locked, serving as a reward for his personal initiation and leadership of this philanthropic mission. The unlocking mechanism is directly tied to the long-term value of the project: only when the total market capitalization of \$ODOM surpasses \$15 billion will this portion begin to unlock gradually. If this market cap milestone is not reached, the tokens will remain permanently locked and never enter circulation.

### 3.4.2 Public Welfare Fund Usage and Locking Mechanism

5% of the tokens allocated to the drug rehabilitation public welfare fund will be locked for the long term, exclusively dedicated to supporting global drug rehabilitation centers, mental health education, and other initiatives related to the promotion of sobriety culture. These tokens can only be unlocked for use once the total size of the fund reaches \$10 billion, ensuring that the public welfare goals remain tied to long-term value and are not influenced by short-term interests.

- The public welfare fund will be stored in a multi-signature wallet to enhance the transparency and security of fund management.
- All fund disbursements require joint signatures from at least three parties: a public welfare advisor, a community representative, and a technical operator.
- The purpose and execution results of each fund disbursement will be disclosed on the blockchain and official channels, subject to global community oversight and scrutiny.
- The list of beneficiaries and progress reports for the public welfare projects will be regularly published to ensure that every token used is accountable to the mission and transparent to the public.

## 4. Public Welfare Mechanism Design

In the vision system of ODOM, public welfare is not a subsidiary, but one of the core missions. We believe that the power of blockchain should not be limited to wealth creation but should also drive the generation and transmission of social value. ODOM, through verifiable on-chain welfare mechanisms, is committed to building a sustainable, transparent, and truly impactful global public welfare support system.

### 4.1 Public Welfare Fund Usage Planning

ODOM's dedicated public welfare fund (accounting for 5% of the total supply) will focus on the following key areas to ensure that the funds are directed at the root causes of addiction issues and maximize their social impact:

**Addiction Rehabilitation Center Construction and Operation:** We will support addiction rehabilitation center projects worldwide, including but not limited to facility construction, operational funding, and rehabilitation program optimization. Our goal is to help those deeply trapped in addiction to re-enter society and regain hope.

**Mental Health Awareness and Education:** ODOM will invest in the development of educational resources in the mental health field, promoting addiction prevention, self-awareness, emotional management, and other key knowledge globally through schools, communities, and online platforms. This will effectively increase public awareness of mental health and help more people learn how to cope with life's challenges.

**Community Courses and Empowerment Programs:** We will establish specialized counseling courses, peer support group programs, and mental health workshops for adolescents and high-risk groups. These programs will aim to break the social stigma surrounding addiction, promote early intervention, and provide support and care for individuals in difficult situations.

Digital Public Welfare Platform Development: ODOM will also develop an exclusive digital public welfare platform, allowing global users to track in real-time the direction and impact of each donation. This platform will record all on-chain charitable donation trails and display a global map of public welfare collaborations. Through interactive modules, we will encourage more users to actively engage in charitable actions, forming a global consensus and cooperation.

## 4.2 Transparency Mechanism

ODOM is committed to ensuring that every fund allocation is clearly verifiable and that every act of support can be witnessed by the global community. To achieve this, we have designed a comprehensive full-chain transparency mechanism that leverages the strengths of blockchain technology to ensure all project funds are used with maximum transparency and efficiency.

- **On-Chain Records & Multi-Signature Security**

Public welfare funds will be stored in a multi-signature contract address, with all transfers requiring approval from multiple independent parties. This significantly reduces the risks associated with single-point decision-making. All disbursement records will be permanently stored on-chain and made publicly accessible, allowing anyone to track the movement of funds in real time via blockchain explorers. Every donation will be traceable and verifiable.

- **Regular Disclosure & Proactive Reporting**

ODOM will regularly publish monthly briefs and annual public welfare reports, detailing the use of funds. These reports will include itemized expenditures, lists of beneficiary projects and institutions, implementation progress, and impact evaluations. Through this public information, global community members will have the opportunity to oversee project execution, offer feedback, and ensure the initiative remains aligned with its original philanthropic goals.

### • **Third-Party Audit Support**

As the ODOM project grows, we will engage reputable third-party audit firms to conduct dedicated audits of our public welfare funds. This will further enhance transparency and credibility. Audit results will be published through public channels to ensure that every transaction can stand up to rigorous scrutiny.

## **4.3 Public Welfare Partners**

The ODOM project will establish in-depth collaborations with charitable organizations across various sectors to jointly advance global efforts in addiction recovery and mental health. We plan to collaborate with the following types of institutions:

- **International and Regional Non-Profit Organizations (NGOs):** We will partner with public welfare organizations that focus on addiction treatment, mental health support, youth prevention education, and other related fields to jointly promote philanthropic initiatives on a global scale.
- **Mental Health Institutions and Hospitals:** ODOM will work with professional mental health institutions and hospitals to support the development and promotion of effective addiction treatment programs. These partnerships aim to enhance the global capacity for intervention and provide professional care to individuals in need.
- **Celebrity-Initiated Foundations:** We will also collaborate with foundations established by reputable public figures—such as celebrities, athletes, and entrepreneurs—who have a proven track record of charitable action. These partnerships will help amplify our social impact and raise public awareness and support for ODOM's mission.

The list of official partners will be announced progressively as the project develops. Community members will also have the opportunity to vote and recommend potential partners, ensuring that ODOM's public welfare initiatives remain open, inclusive, and democratically governed.

## 5. Community Incentive Mechanism

### 5.1 Trump Dinner Event & Initial Consensus Airdrop

ODOM firmly believes that a truly strong community is built on shared beliefs and active participation. To incentivize early consensus participants, promote a culture of public welfare, and empower users with meaningful benefits, we have allocated 20% of the total token supply to establish a long-term, community-driven incentive system.

- **Participant Rewards**

To support the community-initiated "Trump Dinner Participation Plan," ODOM will utilize a smart contract to securely collect TRUMP tokens from participants. Upon conclusion of the event, all TRUMP tokens will be fully returned to their original addresses without loss. Wallets that successfully participate will receive an airdrop of \$ODOM tokens, honoring this historic act of collective consensus.

- **Exclusive Rewards for Early Supporters**

The project will distribute a special airdrop to the top 1,000 addresses holding the most \$ODOM tokens.

ODOM aims not only to reward early trust and support, but also to infuse the community with grassroots vitality—empowering every pioneer to become a co-creator of the sobriety movement and a seed force in a global public good initiative.

### 5.2 Community Co-Creation and Outreach Incentives

ODOM believes that the true power of a project lies in the collective creativity and resonance of countless real individuals. That's why we've established a Community Incentive Pool to encourage everyone who aligns with the spirit of sobriety and discipline to contribute in their own unique ways and inject new energy into ODOM.



**Content Creation Rewards:** Community members are encouraged to write articles, produce short videos, and create social media content that promotes the concept of "sober self-discipline." Rewards in \$ODOM tokens will be granted based on the quality and reach of the content. Outstanding works will also gain additional exposure and official recognition.

**Event Planning and Execution Rewards:** Users are encouraged to organize both online and offline events—such as educational talks, community meet-ups, and charity sales—to expand ODOM's social impact. Token rewards will be distributed based on event effectiveness and engagement.

**Educational Promotion Rewards:** Community members who actively educate those around them on addiction prevention and recovery will receive token incentives, helping to spread a culture of healthy living on a global scale.

Through these incentive mechanisms, ODOM aims to cultivate a worldwide network of sobriety culture advocates—transforming public good into not just an act of giving, but a living, evolving lifestyle.

## **5.3 Preliminary Governance Mechanism**

ODOM is not a project controlled by any centralized authority. Its ultimate destination is to be wholly owned by its community. We believe that power, responsibility, and value must be equally distributed to those who truly care and take real action.

### **5.3.1 Initial Governance Framework**

In the early stages of the project, we will introduce decentralized governance tools such as Snapshot, allowing \$ODOM token holders to directly participate in decision-making processes, including but not limited to:

- **Proposal Rights:** Any community member can submit proposals regarding token usage, public fund allocation, community events, and more.
- **Voting Rights:** All token holders can vote on proposals, exercising their democratic rights based on the number of tokens they hold.

- Transparent Disclosure: All proposals, voting results, and execution records will be permanently stored on-chain and made public, enabling real-time supervision by the global community.

### 5.3.2 Future DAO Development

As the ODOM community matures, we will gradually evolve into a more complete DAO structure, including:

- Governance Token Issuance: Distribute governance tokens to active users and contributors, broadening participation in community governance.
- Smart Contract Automation: Implement smart contracts to automate governance processes, further enhancing decentralization and transparency.
- Token Incentives & Power Delegation: Increase governance weight for community members, empowering them to play a more influential role in shaping the project's direction.

## 6. Technical Architecture & On-Chain Transparency

True trust stems from transparency, and true transparency is forged through technology. Built on the Solana blockchain, ODOM leverages its high performance, low transaction cost, and on-chain verifiability to ensure that every fund transfer and every act of public welfare is open, traceable, and tamper-proof, providing a solid foundation of trust for supporters around the world.

### 6.1 Smart Contract Architecture

The ODOM token is issued under the SPL standard within the Solana ecosystem, offering high throughput and minimal fees to deliver a seamless user experience. All public welfare funds will be jointly managed via multi-signature wallets and smart contracts, ensuring a secure, decentralized disbursement process and eliminating the risk of centralized control. In addition, the project will engage professional auditing firms to conduct comprehensive audits of both the token contract and public welfare wallets. The results of these audits will be made public, laying down a transparent and trustworthy on-chain infrastructure.

### 6.2 Data Transparency & Tracking Tools

ODOM will achieve full operational transparency through on-chain data and visualization tools:

- **Visualized Fund Flows:** By leveraging Solana-based analytics platforms such as SolanaFM, Step Finance, and Birdeye, ODOM will publicly display token flows, token locks, and fund utilization.
  - **On-Chain Proof of Public Welfare Progress:** Project updates and progress will be uploaded via decentralized storage solutions like IPFS or Arweave, ensuring on-chain records and permanent archiving, open to public inspection.
  - **Open Data Access:** APIs and blockchain explorer data interfaces will be made available to support developers, research institutions, and regulatory bodies.
- This transparent system not only strengthens ODOM's on-chain trust foundation but also provides a Web3-era technological blueprint for public welfare initiatives.

## 7. Project Roadmap

Centered on the "sobriety culture" initiative, ODOM is launching a global movement that fuses Web3 technology with a public welfare mission on the Solana blockchain. From incubation to global consensus, every step is grounded in real-world delivery, moving toward a future built on trust and empathy.

### 2025 Q1 | Initial Preparations • Laying the Foundation

- Project Planning & Vision Setting: ODOM was officially initiated with a clear mission to support addiction recovery and mental health. Drawing on Lamar Odom's personal journey, the project aims to build a socially impactful on-chain consensus network.
- Preliminary Tech Architecture Selection: Solana was chosen as the launch blockchain, leveraging its high performance and low gas fees to deploy SPL tokens.
- Visual Identity System (VIS) & Brand Development: Logo design, and brand language system were completed—establishing the tone for spreading "sobriety culture."
- Seed Community Recruitment: Early follower growth began on platforms like Twitter and Discord, alongside whitelist campaign teasers.

### 2025 Q2 | On-Chain Launch • Official Debut

- ODOM Token Launch on Solana: The SPL token is officially deployed, with initial security audits completed to ensure contract security and transparency.
- ODOM Official Website Launch: The website integrates project introduction, tokenomics, roadmap, and public welfare vision, providing access for user participation.
